

## Step by Step Instruction


- 1. Log into Employee Compliance and navigate to Personal Trading / Accounts.
- 2. For any accounts that need to be converted: click the row to expand the card and then click "Edit Login".
- 3. This will take you the Open Banking connection flow where will you be asked to authenticate on your banks website and provide consent for ComplianceAlpha to pull your accounts. If prompted by your bank, we recommend that you select the option to pull in all future accounts.
